## BIOGRAPHY

Rob is a partner in Cox & Palmer's Halifax office, practicing in the field of income and commodity taxation. After pursuing a general corporate/commercial law practice in Nova Scotia for the first four years of his career, Rob relocated to Toronto to pursue a commodity and income tax practice, initially with an international accounting firm and subsequently with a Toronto law firm. He returned to Nova Scotia in 1996 to accept a position with the Department of Justice, serving as Financial Counsel to the Province of Nova Scotia. Rob later returned to private practice, joining Cox & Palmer in 1998.

Since joining Cox & Palmer, Rob's practice has almost exclusively involved domestic and international tax advisory services and the implementation of tax-related transactions and business structures. He regularly assists clients with a broad range of income and commodity taxation matters, including the establishment of tax-efficient business organizations, devising and executing corporate reorganizations, establishing discretionary family trusts, implementing estate freezes and business succession plans, and advising clients on the taxation and commercial law implications of both domestic and international business transactions.
